User or you Any third party that accesses the Website and is not either (i) employed by Computer Forensics Online Limited and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Computer Forensics Online Limited and accessing the Website in connection with the provision of such services;

Scope of this privacy policy

Data collected

Our use of Data

Third party websites and services

Links to other websites

Changes of business ownership and control

12. Type of Cookie Purpose

Strictly necessary cookies These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services.

If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.

33. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

34. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
