Withdrawal of your consent to the processing of data

Some data processing operations are only possible with your express consent. You can withdraw your provided consent at any time. An informal communication per email is sufficient for the withdrawal of your consent. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

Right to lodge a complaint with a supervisory authority

As a data subject, you have the right to lodge a complaint with a supervisory authority in the case of a violation of data protection laws. Right to data portability

You have the right to have data delivered to you or to a third party that we process by automated means on the basis of your consent or an agreement. Data will be provided in a machine-readable format. Should you demand direct transfer of the data to another controller, data is only transferred where and to the extent technical feasible.

Right of access, right to rectification, blocking, erasure

Within the scope of applicable statutory provisions, you have the right to demand information free of charge on your stored personal data, the source of the data, the recipients of the data and the purpose of data processing and, if applicable, you have the right to demand rectification, blocking or erasure of data. SSL and TLS encryption

Our website uses SSL and TLS encryption for security reasons and to protect the transmission of confidential content that you send to us as the website operator. This encryption prevents third parties from reading the data that you transmit via this website. You can recognise an encrypted connection in the address bar of your Browser and the lock symbol in the Browser bar.

Data transmission when concluding an agreement for the purchase and shipping of goods

Personal data is only transmitted to third parties if this is required for the performance of an agreement. Third parties may be for example translators, payment service providers or logistics companies. Data are not transmitted for any other purposes, i.e. data are only transmitted for other purposes if you have provided your express consent.

The legal basis for the processing of data is Art. 6 Para 1 point b) GDPR, which permits the processing of data for the performance of an agreement or in order to take steps prior to entering into an agreement.

Registration on this website

You can register on our website to use certain functions. The provided data serve exclusively the purpose of using the relevant offering or service. Mandatory information requested for the registration must be completely provided. Otherwise, we will refuse registration.

We will inform you per email in the case of important changes, e.g. for technical reasons. The email will be sent to the address provided on the registration.

Processing of data provided on the registration is based on your consent (Art. 6 Para 1 point a) GDPR). You can withdraw your provided consent at any time. An informal communication per email is sufficient for the withdrawal of your consent. The withdrawal of consent does not affect the lawfulness of processing before the withdrawal.

We store the collected data on the registration during the period that you are registered on our website. We will erase your data, should you cancel your registration. Statutory retention periods remain unaffected.

Cookies

Our website uses cookies. Cookies are small text files that your Web Browser stores on your device. Cookies help us to make our offerings more user-friendly, more effective and more secure.

Some cookies are "Session-Cookies". These cookies are automatically erased after the Browser session has ended. Other cookies remain, however, on your device until you erase these cookies. These cookies help us to recognise you when you return to our website.

You can monitor, restrict or prevent the setting of cookies with a modern Web Browser. Many Browsers can be configured such that cookies are automatically erased when you close a programme. Deactivation of cookies may result in a restricted functionality of our website.

Setting of cookies that is required to execute electronic communication operations or to provide certain functions you wish to use (e.g. shopping cart) is based on Art. 6 Para 1 point f) GDPR. As the operator of this website we have a legitimate interest in the storage of cookies for the technical flawless and smooth provision of our services. The setting of other cookies (e.g. for analysis functions) is separately described in this privacy statement.

Google Analytics

Our website uses functions of the web analysis service Google Analytics. This web analysis service is provided by Google Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA.

Google Analytics uses "Cookies." Cookies are small text files that your Web Browser stores on your device. Cookies enable an analysis of the website usage. The information

a cookie created on your usage of our website is transferred to a Google server in the USA and stored there. The server location is, in general, in the USA.

The legal basis for the setting of Google-Analytics-Cookies is Art. 6 Para 1 point f) GDPR. As the operator of this website we have a legitimate interest in the analysis of user behaviour to optimise our web offering and, if applicable, also including advertising.

IP Anonymisation

We use Google Analytics in connection with the function IP anonymisation. IP anonymisation ensures that Google truncates your IP address within the member states of the European Union or in other signatory states to the Agreement on the European Economic Area prior to the transfer into the USA. There may be exceptions, where Google transfers the full IP address to a server in the USA and truncates the IP address there. Google will use this information on our behalf to analyse your usage of this website, to compile reports on these website activities and to provide additional services for us in connection with the Internet usage. The IP address transferred by Google Analytics is not matched with other Google data.

Browser Plugin

The setting of cookies by your Browser can be prevented. If the setting of cookies is prevented, some functions of our website may, however, be restricted. You can also prevent the collection of data relating to your use of the website, including your IP address and including subsequent processing by Google. Service agreement for the processing of personal data

We entered into a service agreement for the processing of personal data with Google to fully comply with statutory data protection requirements.

Demographic characteristics used by Google Analytics

Our website uses the function "Demographic Characteristics" of Google Analytics. This function allows for the preparation of reports that contain information on age, gender and interests of a visitor of a page. The source of this data is interest-related advertising of Google, as well as visitor data from third party providers. Data cannot be matched with a certain person. You can deactivate this function at any time. This is possible via an ad-setting in your Google account or by generally preventing collection of your data by Google Analytics as described in item "Objection to data collection".

PayPal

Our website offers payment via PayPal. The provider for this payment service is PayPal (Europe) S.à.r.l. et Cie, S.C.A., 22-24 Boulevard Royal, L-2449 Luxembourg.

When you pay using PayPal, the payment data you entered is transmitted to PayPal.

The legal basis for the transmission of your data to PayPal is Art. 6 Para 1 point a) GDPR (consent) and Art. 6 Para 1 point b) GDPR (processing for the performance of an agreement). You can withdraw your provided consent at any time. Data processing operations performed in the past remain effective in the case of a withdrawal.
