## HALSTOCK VILLAGE FETE - Saturday 31 August 2024, 12.30 – 5pm

**Conditions of entry. Entering the Fete ground will be taken as acceptance of these conditions.**

1. The owners and drivers of vehicles admitted onto the field to unload/load (or park, if given permission in advance), must be covered by a current insurance policy. All vehicles driven are required to be road legal (MOT'd and taxed). All drivers must have a valid and appropriate driving licence for the vehicle.
2. Please observe the 5mph speed limit at all times. Please be aware of children and animals.
3. All vehicle engines must be switched off whilst stationary.
4. No open flames (camping stoves, fires or disposable BBQs) are permitted on the site.
5. Owners and drivers are responsible for any loss or damage to their own vehicles, personal effects and items for sale.
6. Vehicles must enter the site by the designated entrance, to the right of the Halstock village hall car park.
7. **THE FETE OPENS AT 12.30** but we ask traders to be in place between 10.30 and 12.00. **PLEASE DO NOT MOVE/LEAVE UNTIL 5PM AS THERE ARE CHILDREN AND ANIMALS MOVING AROUND. If movement of a vehicle is essential before 5.00pm please contact a Fete Official.**
8. All traders must obey the instructions of the Fete Officials, not endanger or inconvenience any persons or animals on any part of the Fete site or behave inappropriately. Failure to follow these rules will necessitate removal from the Fete ground.
