Conclusion;

Comments

The clear majority of homes in West Huntspill and Alstone are owner occupied, detached and semidetached houses and bungalows.

The heritage of the village is shown by almost 20% of the responders living in houses that are pre-1900 with many being 17th and even 16th Century.

The village grew considerably from 1961 to 1990 but has slowed since, most likely due to the lack of space available.

The number of flats / maisonettes and low cost housing that are available is very low which may be a barrier to young people staying or moving into the village. Since this questionnaire was published Ringstone Court has been completed which does offer some extra low-cost housing.

Comments;

Two thirds of the respondents were against any further housing developments within the village.

Action

With the new housing in Ringstone and the Brue Farm development to begin shortly this further reduces the need for more housing in the immediate area. Whilst each planning application will be considered independently the council will give due consideration to views of the residents expressed in the survey.

Comments

Although the number of houses with cavity wall insulation appears low it is likely that many responders are not aware that they have this form of insulation as it is not easily apparent. Also, the number of old houses with solid walls will reduce the figure.

Houses fitted with combination boilers would not require a hot water tank which would explain the relatively low number.

The inclusion of "Water Saving Device" did cause a little confusion as it was not clear if, for example, external water butts were included rather than more technical mains water saving devices.

The availability of digesters should be made known to residents. Note that discharge consent will need to be approved.

Comments

Of the ten that reported problems with flooding, nine were from surface water not draining off the roads quickly enough causing ingression into their properties.

<u>Action</u>

It can be concluded that the drains and gullies need to be cleared more often particularly during the autumn. This will be actioned where possible.

Seeking Work

Only six people of the households that responded are seeking work at this time. Barriers to gaining employment were given as lack of opportunities and lack of affordable child care.

Of those that responded 70% thought that a jobs vacancy board in the village would be useful.

<u>Action</u>

A jobs vacancy board may be combined within a new notice board to be placed in a location to be decided.

Conclusion

Virtually the entire village is affected by parking issues to some degree. Particular hot spots were given as;

Ringstone, Silver Street, Plymor Road, Millgreen Close, Greenwood Close, Alstone Road, Church Road and New Road during school time.

Given the large number of vehicles owned by residents with almost two per household, and additional vehicles from visitors and deliveries, it is inevitable that issues regarding parking will occur without the major restructuring of the village. However, poor and inconsiderate parking can be alleviated by enforcement.

<u>Action</u>

The Parish Council will invite a Community Police officer to discuss further.

Ideally a purpose built, one-way parking area is needed in New Road opposite the school. This would not only improve the parking situation but would improve the safety of the children.

The residents were asked if they have difficulty getting to the following?

Comments were made that the bus direct to Musgrove Hospital has been stopped and needs to be reinstated. Residents needing to travel to Southmead suffered a difficult journey using public transport.

Conclusion

This may be alleviated in part by use of Sedgemoor Community Transport or a new voluntary car service.

There is an existing Patient Transport Service to Musgrove Hospital that can be contacted on 01278 727444

Voluntary Transport Service

Twelve residents offered to use their vehicles as a voluntary transport service mostly on an occasional basis. The number of residents that said they would use such a service was twenty-one.

Conclusion

There is a service offered by Sedgemoor Community Transport running out of Colley Lane, Bridgwater currently (01278 434881). If an alternative service is to be offered a coordinator will be needed. This should be followed up with a viability study.

A further alternative would be for the village to purchase a community bus. Again the viability of this needs to followed up.

Road Safety

The residents were asked if there were any major danger spots on the roads in West Huntspill.

Main Road -	Cars racing late evenings, speeding motorbikes
Side Roads -	Alstone Road parking leaves insufficient width for fire engine. Many reported speeding in New Road
Crossways junction -	Poor visibility when turning right out of Church Road Poor visibility when pulling out of Withy Road Pedestrian Crossing needed to Bus Stops
School -	School hedge restricts visibility when tuning out of New Road
Others -	Poor visibility when turning out of Ringstone due to parked vans

Cont.

Poor visibility when turning out of Orchard junction due to parked cars and pub signage. Cars parked very close to junction are a danger.

Poor visibility when turning out of Langlands Lane Cars parked near car wash causing obstruction Sloway Lane very narrow with much traffic to and from Laburnum House.

Of those quoted as "other" included; Speed camera to be reinstated, footbridge near the school, flashing digital 20mph sign near the school.

Conclusions / Actions

Several measures could be employed that will need to be followed up with the relevant authorities;

- Pavement on west side of the Main Road from Church Road north could be widened.
- A mirror opposite Church Road entrance near The Common should be considered.
- The school hedge should be cut lower.
- Traffic calming in New Road to the Cricket Field should be considered.
- The size and location of signage should be discussed with the manager of the Orchard Inn to try and improve visibility for traffic emerging from Church Road.
- A double mirror should be placed opposite Ringstone entrance.
- Repeater signs and double yellow lines near junctions could be installed.
- Parish Council to consider purchase of speed indicator.
- A 20mph speed limit should be considered in New Road near the school.
- A pedestrian crossing across the A38 is needed. Suggest location near the chapel.

In relation to paths, footpaths and streetlights the residents would like to see the following;

Comments;

With regard to street lighting those along Main Road could be dimmed during the night and early hours. However, many areas of the village were seen to be poorly lit. In particular Church Road and Smurl Lane. There is only one designated bridle path in the village currently.

<u>Action</u>

The Parish Council is aware that there is program of street light replacement to the LED type provided by the County Council. It will make enquiries as to the details and timescale of the replacement program and assess if this will alleviate some of the issues raised and consider light dimming along Main Road. The Parish Council will also press for an extra street light in Smurl Lane.

Residents were asked what could be done to improve the environment in the village.

A summary of the comments made follows;

- Remove Car Wash
- Reduce Traffic
- Improve street lighting in Church Road
- Provide more dog bins / Reduce dog mess
- Plant bulbs along A38
- Provide community shop
- Reduce litter / more litter bins
- Improve maintenance of The Common
- More frequent hedge and verge cutting
- Clear drains more often
- Improve maintenance of rhines
- Entrance to memorial playing field untidy and sign needs replacing.
- Improve communication to residents
- Enforce rubbish removal from gardens (Ringstone)
- More bridleways and droves needed
- Prohibit ball games near housing
- Less clay pigeon shooting

The most repeated comments were the need for a local shop and reduction of dog mess.

<u>Action</u>

The Parish Council will consider all the above and form an action plan to implement improvements where possible.

Conclusion /Action

It is of great concern to the Parish Council that any residents should feel unsafe anywhere in the village. Regarding light levels this can be alleviated by improving street lighting as per the previous section.

The Parish Council will continue to try and get a pedestrian crossing installed across the A38 at a location that will benefit most residents.

Members of the Parish Council will plan a site visit to the sea wall and corner of Orchard & Greenwood Close to assess.

Residents willing to take part in "Clean Sweep"

It was pleasing to see that 58 residents said they would willing to help with the Clean Sweep to remove litter from our village.

Village Facilities

Standard of Village Services

The residents rated the services from very poor (0%) to very good (100%)



Those given the lowest score was the community police and hospital transport.

The reasons given were a total lack of visibility of Community Police and many residents not aware that there was a Hospital Transport service.

Action / Conclusion

The Parish Council will invite the Community Police to a meeting to discuss how their visibility can be improved. The transport services available will be advertised in the Church Magazine and on noticeboards.

Rating of Village Utilities

The residents rated the utilities from very poor (0%) to very good (100%)



Conclusion.

The broadband speed varied widely across the village. This is largely due to fibre optic cable being available in some areas of the village only. Since the questionnaire was published a new connection has been made near the common.

<u>Action</u>

The winter weather service could be improved by the installation of more road grit stores. The Parish Council will seek improvements to the maintenance of roadside care and streetlighting.

State of Areas and Facilities

The residents rated areas and facilities of the village from very poor (0%) to very good (100%)



Comments

No area received a rating of "Very Good" (80-100%) and only The Common and street furniture being viewed as "Good" (60 - 80%). The lowest rated were the road surfaces, pavements, verges and hedges although they were all in the "Fair" category (40 - 60%).

Conclusion.

Many residents may not be aware of the restriction in cutting hedgerows from April to September due to bird nesting. Due to the timing of the questionnaire it is likely that much of the overgrowth has been cut back and hedges trimmed.

It is pleasing that The Common scored highly and some work has been completed since the questionnaire was published. Additional work is planned to reduce bushes and hedgerows.

<u>Action</u>

There should be a clear system put in place for residents to report any issues directly to the Parish Council in order that it can press for rectification directly with the relevant authorities. The council is aware that agency cut backs have reduced the amount of maintenance available.

Residents were asked if they knew where all the local footpaths and bridle ways were and if they had experienced any difficulties?



Further comments;

Mud & Water - Path near allotments very bad

Barbed Wire – Blocked near Methodist Church

Bushes & Nettles – Especially bad - Alstone Footpath, Main Road, Stoney Path & back of Caramia Park

Other – Dog mess, not pushchair friendly, Some stiles need repair, path New Road to Highbridge obstructed by fallen trees.

Don't use - Not dog friendly

Many have said that a map of local footpaths would be very useful.

Conclusion

A program has been put in place for the members of the Parish Council to review all local footpaths and report any issues found. There is an online facility to view all local footpaths with the ability to report issues at http://roam.somerset.gov.uk/roam/map#. This needs publicising to the residents.

<u>Action</u>

Maps should be made available at locations such as the church, in noticeboards and local pubs.

<u>Ilex Park</u>

Only 13 of the respondents used Ilex Park and no one has offered to assist with the maintenance of the play area.

Many stated that they didn't know where the park was and some said that it was seen as for the exclusive use of children from Ringstone.

Conclusion.

The Ilex Park has been subject to a complete refurbishment this year and is a credit to the village.

<u>Action</u>

A sign or plaque should be installed close to the public footpath entrance to the park. The location and responsible person contact details should be advertised.

Allotments

There were six residents that would like an allotment. However some expressed issues with the area particularly with regard to flooding, poor soil and theft from plots.

It is noticeable how few people use the Parish Council website as a source of information. Further it is felt that the number of residents receiving the Church Magazine only accounts for about a third of the households in the village.

Crimes & Anti-Social Behaviour



The respondents expressed concern of the following crimes and anti-social behaviour.

Comments

Many of those in the "other" category included dog fouling whist some included that in "litter".

Conclusion

The number of residents that had been a victim of crime or anti-social behaviour was fairly low at eleven. Four reported being a victim of anti-social behaviour, one burglary and one theft. The remainder did not give a reason.

<u>Action</u>

The Parish Council will discuss the findings with the Police and Community Police.

Any issues, suggestions or concerns not previously covered

The most frequent issues raised was with regard to parking and need for a local shop.
