We had access to the prison cell block & Nissen Huts 27, 33, 41, 42 and 53

Entrance:

Before starting the investigation Julie stated that she could sense a battle scene on the field. She believes it was the Jacobite rebellion from 1745/1746 as she could see the red coat army.

On arrival of Alex, Maryann and Nigel it was stated that on the journey Maryann was getting the number 27. She did not

know at this time we had access to Nissen Hut 27, but was convinced that we should start our investigation there.

Prison Cell Block:

Julie had a walk around outside and stated that she was drawn to hut 42 and that it had a strange energy. She was unaware at this time that we had access to this hut.

Julie left the room as she felt drawn outside while we were preparing our equipment. She returned and said that she felt that she was being shouted at outside and being told to 'stop slouching' and felt as if she was being marched.

Julie said that she felt there was someone marching up and down the cell block.

We decided we would come back to this area as nothing else was happening.

So at this point we split into two teams.

Nissen Hut 42:

Team 1's experience ...

Julie stated that before entering the hut she felt like it had been a medical area. Once in the Hut Julie felt quite a significant drain in energy. She also mentioned that she felt as if the injured were soldiers not POW's.

Whilst conducting some EVP experiments, the walkie-talkie kept going off. It was later discovered from Team 2 that they were not trying to contact us and that it had actually been placed on a table.

In the second section of the hut, whilst sitting conducting the EVP experiments, Zoey and Lorraine both heard a noise by the door. There was wildlife in the area so could perhaps be explained rationally.

Julie mentioned that her head was pounding and her torch battery was draining. So we returned to the equipment area to remedy the situation.

Team 2's experience ...

Initially the hut felt quite quiet until we moved into the second section of it.

There, we encountered a spirit which appeared to be shy in coming forward to expressing any details about itself, so sadly this is unverifiable as we had nothing else to go on.

We were also experiencing some interference on the walkie-talkie. We thought Team 1 was trying to communicate with us but their walkie-talkie was switched off.

Prison Cell Block:

Team 1's experience ...

Julie stated that there was a lot of energy on the doors 18 and 19. She believes the occupants spent a lot of time leant up against them communicating with each other. She stated that the energy had a very depressing feel to it.

We conducted some EVP experiments here.

During these sessions, Julie felt a cold breeze on her leg despite the fact that she was sweating due to the heat.

Whilst continuing with the EVP session Julie stated that the male that was coming through on the recorder would not speak to a woman. Mac then stepped in to ask a few questions.

Once we had finished the recording session, Lorraine felt as though someone had walked behind her as she was walking towards the cells. She quickly turned around but no-one was there.

At the door entrance of cell 19, Mac stated that the hairs on the left side of his face were sticking up. He did not feel uncomfortable by this, it was purely an interesting sensation to feel.

A locked off infrared camera and laser grid was setup in an attempt to capture something while there was no-one in the building.

Team 2's experience...

The main point of interest for us was in the first cell on the left-hand side.

We noted an energy presence there with impressions of choking from a possible hanging but it did not look like you could have hung yourself from inside the cell so we surmised that perhaps it was a residual feeling from the spirit to indicate his fate. We also recorded some EVP recordings here.

Nissen Hut 41:

Neither teams sensed anything, or achieved any unusual results from this hut.

Nissen Hut 53:

Team 1 & 2 experienced the same here ...

Upon entry to this hut we discovered a bird nest and as the birds appeared to be distressed by our presence we decided to leave the hut.

Nissen Hut 27:

Team 2 had started their investigation here and had left locked off cameras in this hut. The ultraviolet camera had finished recording and so we switched off the infrared camera too. Some EVP experiments were conducted here but we were not getting much.

Team 2's experience ...

For our team, this is what made the night for us. We all experienced an isolated smell of burning which we could not detect elsewhere in the hut nor outside. Although later on during the night we could smell something similar to a coal fire from a chimney further away but these smells were different.

The smell was noted as we were attempting to converse with the spirit of a submariner who's u-boat had been hit then he was imprisoned in the camp.

There were flickers of responses in the EMF meter to Nigel's questions to the submariner which he was particularly amazed at combined with the localised smell of burning.

Battery life in our equipment seemed to also be affected so we setup some trigger lights and asked if the spirit would be able

to continue affecting the equipment in the same way while the cameras were running.

On returning to the hut the light was off. Unfortunately there was a giant moth which was discovered in the hut, so the footage was contaminated.

Hut 33:

Zoey felt a cold draft in the middle of the room between the 2 windows at the back; to note, it was quite a warm and humid night that night with barely a breeze in the air.

Lorraine also felt a cold draft in the middle of the room between the front 2 windows; all windows were closed. However as this feeling was experienced between windows there could be a natural explanation for this; a micro-climate with a lower temperature. We did not have the thermal camera with us to detect that.

Julie felt a feminine energy with this hut but nothing else.

Team 2's experience ...

No results from this hut.

Teams reunited, Hut 27:

There was a spike on the EMF meter which was laid on the table in front of us.

Maryann stated that she heard a voice from the bar area but couldn't quite make out what was said. She also mentioned that the same spirits from their team's previous visit were still there.

Julie could see a pair of legs walk past the bar area.

Previously Nigel's and Macs camera had drained of battery power but to our astonishment both cameras came back to life with a suitable amount of battery left in them.

This was to be the end of our investigation as time had beaten us one more.
