The Banshee Labyrinth

1st Visit

What an exciting investigation this one turned out to be. We had only walked into the "Mary Queen Of Scots Room", when Maryann started to sense a spiritual presence straight away.

We hadn't even opened the cases or started filming when she went on to say that she could see a man that appeared to be dressed in a suit. She felt that he was an undertaker but did not appear to be interacting with us at present.

We quickly setup the camera to record Maryann's accounts and hopefully capture something on film.

We managed to record anomalous readings with an EMF meter which we could not explain. The meter would fluctuate significantly and stop or remain strong for extended periods of time.

The readings were the most significant at one of the tables booths so we began to setup coins as trigger objects and asked the spirit to kindly move them if they were able to. Several of us witnessed the coins position at the time. I then retrieved a tri-pod and infrared camera to record the lock off experiment but in the time of setting up the coins and returning with the camera which was in the same room, the coin at the top had moved. The team will attest to the fact that no one was near the coins in-between that short space of time.

We were astonished as the trigger objects generally do not move once set up. We took more EMF readings and they came back strong at the coins.

We attempted to move the coins by banging on the table or nudging it, without success. There was also no heavy traffic outside which may account for vibrational movement.

Fascinated, we set up the camera to record the coins and attempted to capture some EVP recordings, so we set out to ask some questions, which after asking the spirit to introduce itself, an almost clear recording of what sounded like "Mathew" was heard.

Everyone was excited by this, but unfortunately after analysing the recording it turned out to be me saying "thank you".

On returning to the room we discovered that the coin had been moved once again so I eagerly checked the locked off camera footage only to discover right at the tail end of the footage that the Tri-field EMF meter began to register a disturbance in the energy field in the room but then the footage cuts off.

The battery that was used for the camera still had plenty of life in it and so it appears the camera was switched off or malfunctioned in some way. Further tests have been conducted on the camera to ensure the equipment was not faulty so we are unsure what happened here, but we do not have footage recorded of either movement of the coins.

The floors are hard wood and the entrance to the room has a creaky staircase and heavy door so the camera would have detected sound should someone physically have crept in to turn the camera off. It was very strange indeed.

The next room that we encountered some activity was the "Cinema Room". Maryann had sensed a presence sat next to Zoey.

It was a huge dog, which initially struck concern because of the size if it but it showed no malice, more protective than anything.

Maryann went on to describe the dog and Zoey confirmed that it indeed sounded like Maryann was describing her pet dog which has now passed.

Some EVP's were recorded here but nothing too discernible; however, we shall continue to analyse these and report any new discoveries.

Lastly the "Chamber Room" was where we would encounter our final experience of the night.

Maryann had detected crossing ley-lines running through this room together with a strong sinister male spirit and a female presence too.

The man appeared to be quite angry that we were in his living quarters without invitation.

"So many people trespassing without invitation".

Maryann started to sense the man's energy more strongly and began to feel a choking sensation.

She believed that this horrid man would have taken women back to his place of abode and strangled the life from them. He was a nasty piece of work and one that she had to take a brief time out from to collect herself.

There were strong EMF readings in this area but the place was wired for live gigs. Even though the gear was switched off at the mains we took this into consideration.

We found the centre spot of the crossing ley-lines and attempted a table tipping experiment. Sadly there was no movement with the table but there were strong EMF fluctuations which were detectable above, below or around the table.

It was an uncomfortable feeling in that room compared to the others but we were running out of time so we had to call it a night.

Post investigation, Zoey has proven through research that there was a funeral home next to where we were investigating and that the man that we encountered that would choke his victims did indeed do that.
