Way back in 2001, prior to the construction work commencing on Elsea Park, the plans to manage such a large development were formulated and this led to the Section 106 (S106) Agreement being established.

> he S106 stipulates the provision of a shuttle bus for the development to connect with the bus stop on the A15. When the Trust came to implement the service, the residents were consulted to ascertain the desire for this to be provided. It was determined by residents, at an AGM, that there would be little use for this and subsequently not worth the expenditure, so a formal vote agreed that this should be deferred to a later date.

We broached the subject again a few years ago, and we were just about to launch a trial service as

- COVID-19 restrictions came into effect. Now that the restrictions have lifted, we believe we are at a point to try again. We have, however, reevaluated our approach and we need the assistance of residents to inform the actions we take.
- We've put together a short survey to ascertain your views on whether this is needed and, if so, what this service should look like. There would be no cost to use the bus each time you wanted to, but it would be funded through the Yearly Payment. As we are currently embarking upon a process to rebaseline the Yearly Payment, we need to determine the anticipated costs to run the bus and ensure the fees we pay cover this. For this reason, we need your valuable input to guide the action we take; after all, it's the service you'll be using and paying for.

We are very fortunate to live in a safe and welcoming community. There are countless occasions when our wonderful community spirit has been demonstrated to raise awareness of ASB (antisocial behaviour), criminal activity and other unwanted behaviour.



here's always more that can be done, so, by signing up to the Neighbourhood Watch Community Safety Charter, we're signifying our commitment to ensuring Elsea Park remains an area that does not tolerate unacceptable behaviour and we need you to be part of this endeavour. It's really important that any instance of ASB is reported to 101 and we strongly encourage residents to do this, even if you know someone else has already done so.

The aim of the Community Safety Charter is to involve a

wider range of local organisations, charities, businesses and groups in crime prevention activity and extend the scope of this work towards a goal of eliminating harassment, antisocial behaviour, and intimidation experienced by anyone who lives, works, studies, or visits anywhere in England and Wales.

The Community Safety Charter is a means by which Neighbourhood Watch members, local residents, businesses, and organisations, agree to do whatever

they can together to provide an environment that is safer for everyone, and help us to meet this goal by committing to:

- Promote a culture that does not tolerate harmful language, antisocial behaviour, or hostility towards others.
- Enable others to identify and take an active stance against harassment, antisocial behaviour, and intimidation in your local area.
- Take seriously all reports and disclosures made to you or your organisation and actively encourage and support individuals to report harassment, antisocial behaviour, and intimidation. Share what you witness about these crimes with the relevant authorities.
- Do what you can to help individuals affected and signpost victims to relevant support agencies.

A FRIENDLY **REMINDER**



e all value our open space, and we are very fortunate to have so much right on our doorstep. The well-equipped play areas bring a lot of fun and excitement to many families, which is great to see, and we want everyone to be able to enjoy them. For this reason, we do discourage certain activities.

JUST A LITTLE

Dogs should never be taken inside a fenced play area, unless they are service dogs. There are various reasons, such as allergies, fears and phobias, and of course the risk of Toxocariasis. We kindly ask that you keep your dog out of these areas for the safety and wellbeing of everyone.

COLUMN TOUR

As a further reminder, the AGP can be accessed by residents for free on Mondays and Fridays between 5pm and 6pm.

We still need you to book in and accept the T&Cs, but it's a great opportunity to use this amazing facility.





Football can also be problematic in these spaces, more so with older children as they tend to kick the ball harder. This will often result in the ball leaving the confines of the play area, and inevitably hitting houses or parked cars. Nobody wants their property to be damaged, nor would anyone want the expense of having to pay for damage that has been caused due to a wayward ball. We recommend finding a more suitable location that won't become a nuisance to those living adjacent to a play area.

DEVELOPER UPDATE



Tilia Homes have met with the chosen contractor for a further inspection of the roads and paths.



heir report has been sent to Lincolnshire Highways for their comments. Some of the older areas, such as The Gables and The Pollards should see work commence in September and further correspondence will be shared with the Trust for onward dissemination.

Jubilee Green play area has been sprayed up until August. Depending on the weather, the area will

be rotavated in August or September, the grass matting will be installed and seeding put down. It is anticipated that the play area will be opened in October, but this is subject to the grass becoming established and a certified RoSPA inspection.

Jubilee Green, the space adjacent to the play area, is being frequently cut in an effort to suppress the weeds and encourage the grass to become established. It's having a positive effect so far, but it is likely that some areas will require rotavating and seeding, and any further necessary work will be assessed and undertaken accordingly.

The Local Area for Play (LAP) adjacent to Wincanton Way has been cleared and prepared for the next stage of work. This is anticipated to take place during August.

Work on the play area next to the AGP will commence as soon as the Jubilee Green play area is finished. Once this play area has been completed, the landscaping and remedial work will then commence on Ogrey Pool. This is likely to be started in September or October, but it is subject to the completion of other tasks and weather conditions.

Plans for the extension of Chequer Tree Walk, the land above the high-pressure gas main at Newton Abbot Way, will be jointly discussed between Tilia Homes and the Trust in due course.
